DOES MY BUSINESS HAVE TO BE LOCATED IN LINCOLN PARK TO BE A MEMBER?

Businesses do not have to be located in Lincoln Park to be a member. Businesses located outside the boundaries of Lincoln Park find that their association with LPCC allows them to extend their business base and generate revenue through their contacts.

SPECIAL SERVICE AREAS

For more than 29 years, the Special Service Area (SSA) program has provided communities with the financial means to create, maintain and manage clean, attractive and competitive commercial districts. SSAs, known as Business Improvement Districts in other cities, provide a fair and transparent way to finance and manage improvement programs in communities that benefit business owners, residents and visitors.

The LPCC is currently responsible for the management of two SSAs - the Clark Street SSA #23 and the Lincoln Avenue SSA #35 - and works to implement new programming to help spur economic development along these key commercial corridors.

CLARK STREET SSA #23 "CLARK STREET IN LINCOLN PARK" VISITCLARKSTREET.COM

The Clark Street SSA includes all properties fronting Clark from Armitage on the south to Diversey on the north. In addition, it includes all properties fronting the south side of Diversey from Orchard to Lakeview. The Chicago City Council passed the establishment ordinance for the Clark Street SSA #23 on December 4, 2002. The SSA was reconstituted (renewed) in December 2008 for 15 additional years.

Clark Street in Lincoln Park is at the heart of the neighborhood and known for its boutiques, restaurants, bars, and clubs. But this happening haven is about so much more than drop-dead-gorgeous clothes and thrumming nightlife. It's one of our nation's finest urban playgrounds.

Some of the many accomplishments achieved by Clark Street in Lincoln Park in 2010 and the first half of 2011 include:

- Logo and brand development • New website and social media engagement
- Installation of 20 bike racks to promote alternative transportation
- ConnectCLARK meetings to develop camaraderie amongst businesses on Clark
- Art on Clark - an initiative to fill available vacant storefronts with local art
- Development of a business attraction piece
- Halloween "Spooktacular"
- Street cleaning, pressure washing and snow removal
- Seasonal landscaping and holiday decorations

GOVERNMENT RELATIONS AND COMMUNITY AFFAIRS

The LPCC speaks on behalf of our members in a unified voice to promote the responsible solution to impending changes politically or on a community level. The LPCC is committed to its role as the "voice" of business in Lincoln Park and advocates on behalf of the LPCC's members at the state and local level. Whether you are concerned about transportation, taxes, zoning and development, or business regulation, the LPCC has your business interests at heart. The LPCC's advocacy efforts are focused on driving economic development and job growth to ensure that Lincoln Park continues to be a vibrant place to do business.

The LPCC's Government Affairs Committee officially formed in January 2008 to take a proactive approach to legislative issues affecting the Lincoln Park business community. The Government Affairs Committee performs issue and policy research, and recommends policy positions, including a yearly legislative agenda, to the LPCC Board of Directors. The committee also works with elected officials to propose legislation that will enhance the Lincoln Park business community.

The LPCC has strong working relationships with Alderman Scott Waguespack (32nd Ward) and the numerous community organizations in the Lincoln Park neighborhood. Cultivating a mutual respect for the needs of residents and businesses is something that these partnerships are constantly working towards. The face of the 43rd Ward changed in 2011 when Alderman Vi Daley announced her retirement. The LPCC looks forward to establishing a relationship as strong with the incoming Alderman.
