Financial Report (Davis)

- Financials are good. We have a \$197,000 in the bank.
- We received approximately 90% of our levy in 2022. Almost 35% of that, over \$150,000, came in late in December.
- We spent about 72% of our budget in 2022, so we have about \$125,000 left unspent. But we budgeted for \$100,000 of carryover in the 2023 budget so we will be able to spend most of it this year (2023).

Program Manager Report (Wobbekind)

I. **Chicago Sculpture Exhibit Update:** we have decided to put sponsorship of this program on hold this year. We think this is a great program and see the value of supporting it again in the future but the cost has gone up and with the Under the L project coming up as well as potentially late tax bills, we think it is better to be conservative in spending at the beginning of this year.

II. Contracts:

- **a.** Litter Abatement- Cleanslate will move to their winter schedule beginning Nov 1, they will be out 3 days a week- Wednesday, Saturday and Sunday. We finished up the 2022 contract and starting the 2023 contract. No changes to service
- **b.** Landscaping- planters and baskets will be removed soon and then the winter plantings will go in, as a reminder we are working with the City again, they are using Moore Landscapes.
- **c.** Snow removal contracts are in effect, we had one snow event around December 22. It didn't snow as much as forecasted but it was very, very cold and the crews were limited in the amount of time they could spend outside, plus the salting doesn't work in extreme cold but overall the crews did a good job. Also, over the weekend, January 22 and maybe tomorrow we will have some snow.
- **d.** Holiday Decorations looked great this year, were removed last week.

III. Streetscape:

- a. Under L Improvements- we are working through the process, this week the construction company will be out with ComEd to determine the location of the electrical connection
- **b.** Bike Racks We are still waiting on CDOT for an installation date for the racks.

IV. Public Safety:

- a. There was a conversation with the 18th District police commander event last week, January 18. Robin and I have been attending these; it is helpful to build relationships and connections with the officers.
- b. We are also attending the State's Attorney's Office Northside Community Justice steering committee with the 19th district.
