



**Request for Proposal**  
**Clark Street Special Service Area (SSA) #23**  
**2023-2024 Sidewalk Snow Removal Services**

**Period of Coverage:**

November 1, 2023 – May 1, 2024

**Scope of Work:**

Sidewalk snow removal on Clark Street between Armitage and Diversey, and sidewalk snow removal on the south side of Diversey Parkway between Orchard and Lakeview, wrapping around all corners to the alleys. See attached map for service area. **Snow removal includes at least a 5' path on all sidewalks, complete snow removal from all bus stops, crosswalks, corners, around all fire hydrants, public art (sculptures), wayfinding signs, and around all parking meter pay boxes.** Sidewalk snow removal must comply with current City of Chicago sidewalk snow removal ordinances. Plowing must take place before 7:00 am and 5:00 pm during snowfalls. Communication before and after each snow plow deployment and completion is required with specific time when service was provided. Snow plow team is required to wear SSA-branded vests when performing services.

**Bids to Include:**

1. Cost of seasonal contract for removal of 55" including de-icing
  - a. At 1" tolerance with spreading of non-sodium de-icer per occurrence or as requested
    - i. Three additional de-icings included if requested at no extra cost
  - b. At 2" tolerance with spreading of non-sodium de-icer per occurrence or as requested
    - i. Three additional de-icings included if requested at no extra cost
  - c. Cost for additional services beyond 55"
2. Cost of per-plowing contract
  - a. At 1" tolerance with spreading of non-sodium de-icer per occurrence or as requested
  - b. At 2" tolerance with spreading of non-sodium de-icer per occurrence or as requested
  - c. Cost for spreading of non-sodium de-icer per occurrence
3. Method of snow removal
4. Width of sidewalk plowed
5. Response time for services
6. Method of communication with client for each plowing
7. References

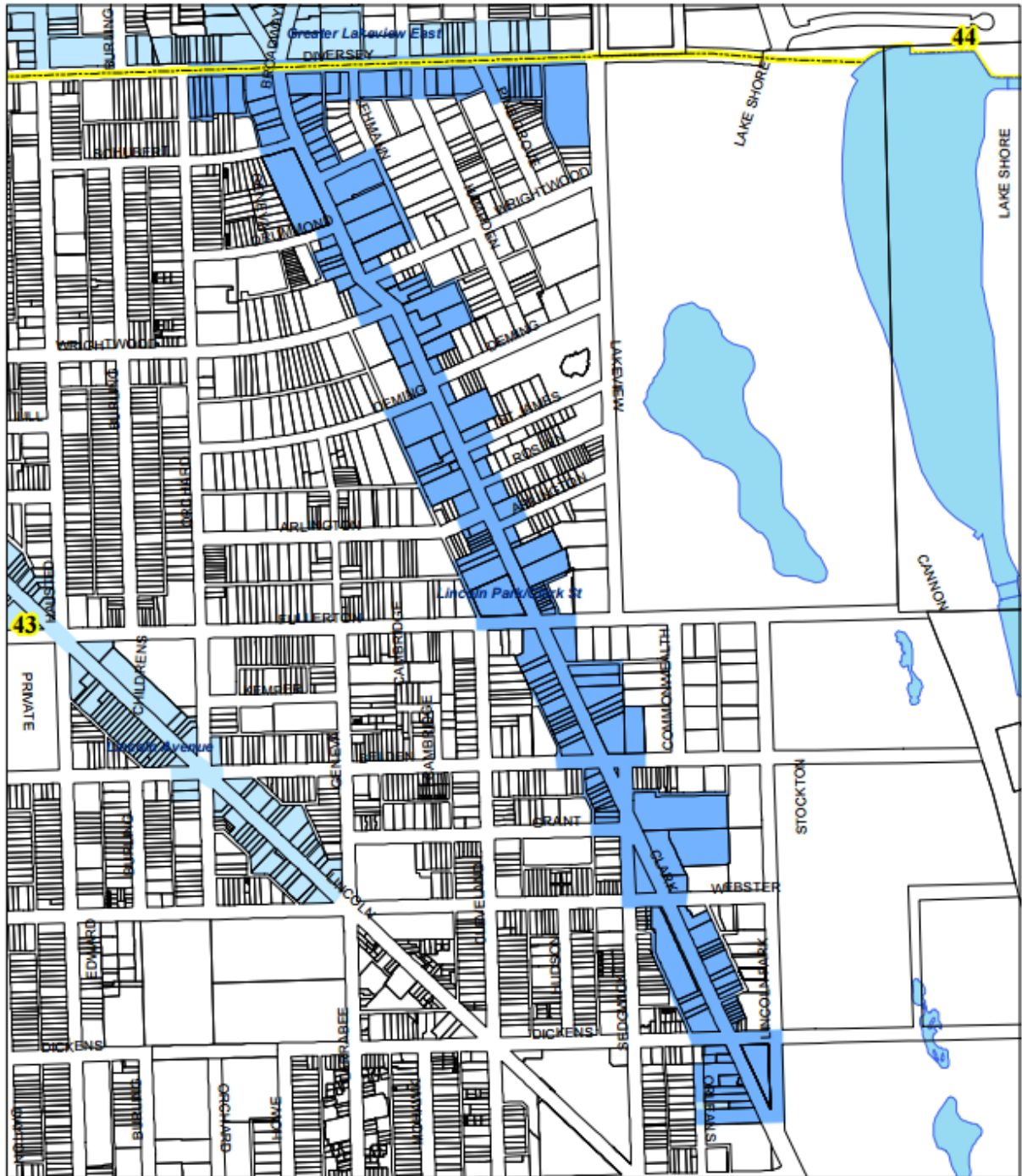
